

Return Policy/Terms & Agreements

There are No Cash, Check or Credit Card Refunds on CD's, DVD's, DJ Services or any other services StarDancer provides. On products such as CD's or DVD's we can swap for a new one. That is and if the product was defective or does not work properly because of a defect. If the defective cause is from a source such as CD players, DVD players, or other devices used to play our CD's and, or DVD's, there is absolutely no refund. If a player or other device player will not play the product up to its specification or potential, there is absolutely no refund. All of our CD's and DVD's properly work in up to date players, unless the CD or DVD is defective. If that is the case our policy is for you to send the defective product back to us, and we will return to you a new product, the same product that was originally purchased on a new CD or DVD at no extra cost to you! This can happen up to three times. After three times StarDancer will refuse to you a refund, swap or exchange. If this happens the third time, we will check the fourth CD or DVD, before we send it out, through our lab, and run a test check up to three times. If it works properly on our player then there will be no need to return the product once again. If fault or damage happens during shipping, return the item with a letter explaining what happened and we will ship you another product at no extra cost to you. If any policy has not been abided by through StarDancer, there are no refunds or swaps.

No refunds if copyright laws were broken. All of our sellable programs have copyrights attached to them. All of our programs are protected by copyright laws. Unauthorized reproduction or distribution of our programs, or any portion of our programs, may result in severe civil and criminal penalties, and will be prosecuted to the maximum extent possible under law. There are no refunds for trying to copy, burn, rip or reproduce our CD's and or DVD's without our authorization. Copying our products is prohibited without our consent.

By signing the purchase order above you agree to the terms and conditions here in this letter or note. You also agree not to copy, burn, rip or use other copy devices of the CD's and or DVD's you purchase from us. By signing the agreement on the purchase order you also agree to and abide to understand that all of our CD's and or DVD's have a code on them and that they can be tracked or found if published on the Internet! By understanding this you also agree not to publish our material, programs, CD's and or DVD's on the Internet. You also agree not to teach our programs on the Internet. You also agree, if found guilty in a criminal court to pay damages that may have or cause harm to StarDancer or their employees or workers and to also pay other fee's such as their legal fee's, their lawyer fee's and any other fee's that StarDancer and their workers may incur due to criminal activity. Also by signing this agreement you agree to if you've made any profit by using any of our programs or material that you would pay StarDancer and its owners for the profit that was made on such sales and events. By signing the purchase order agreement you also agree to not to use any of the programs or material on the DVD's or CD's for profit, employment, or gain, in public, or in a studio, or dance studio, or for a, or in a non or not for profit organization, or the Internet, or a competition, or television, or radio, or the news papers, magazines, or publish in a book, or shows and theatres, or performances of any kind, and or movies, or making your own CD's, DVD's, VCR Tapes, recordings of any kind, also including any kind of media or software, for and or teaching or teaching purposes, or workshops, or explaining, or selling, or giving away material to our competitors, or trading, or representing, or giving away our secrete teaching techniques, or practices as well as selling techniques, or training and exercises, or our teaching style, or teaching or showing the elements of dance, or teaching or showing the following with foot positions, footwork, body and dance positions in relation to your partner, positions with partner in relation to the room, our style of timing and rhythm, character of the dance, our programs and style and the order in which the steps appear on our programs, you cannot compete with or against StarDancer or Linda Landwehr and Stanley Mayer. Teachers familiar with our programs can teach our programs with our permission Only! As long as you are within a 300 mile radius from us. You Must Have Our Permission First! If you are a teacher or dance instructor (certified through the NDCA) you also agree to the terms and conditions to this letter or note you signed at the top of the agreement on the purchase order. If you are not certified you are considered a non teacher of dance unless you are certified through other types of dance organizations such as Jazz and Ballet and has to be recognized through a reputable school or company, and you still have to get permission from StarDancer along with its representatives. All others will have to agree to the terms and conditions of this note, letter or agreement. You must sign the agreement or we will not sell to you! In other words we do not want you to teach, sell, rip, copy, burn, steal our program without our consent otherwise we do not need your money.
